Chairman Mommer called the special meeting to order at 8:07 a.m. Board Secretary Riley Myers took roll call to determine a quorum for the meeting. Mr. Ryan discussed what approach some schools in the area are doing during this time. Options for Voluntary Continuous Learning and Required Continuous Learning methods were discussed. The positive and negative points of each method were discussed and considered.
