## *Public Hearing and Special Meeting*

**PUBLIC HEARING FOR FY20 BUDGET AMENDMENT:** Chairman Mommer called the public hearing to order at 8:00 a.m. Motion by Elizabeth, second by Hungerford to approve the public hearing agenda. Carried unanimously.

Mr. Ryan presented the FY20 Budget Amendment to the Board. Mr. Ryan and Mrs. Myers explained that the budget amendment is just to make sure the school does not go over the budget with the purchase of the iPads and Chrome books for the school. **DISCUSS RETURN TO SUMMER SPORTS PROGRAMS:** Mr. Ryan provided an update to the Return to Summer Sports. Dialogue among board members occur and questions were answered by Mr. Ryan. Mr. Ryan explained that health safety procedures will be put into places for players, coaches, and spectators due to COVID 19. Mr. Ryan stated that a parent meeting will occurred for families that will have summer athletes. The Principals, athletic director, and superintendent will be meeting with players and coaches to explain protocols for practices and games. Board members were offered an opportunity to ask questions and provide feedback.
