1. Call Meeting to Order, Read the Mission Statement, and Approve Agenda

Vice President Crandon called the Special Meeting to Order at 6:30 p.m. Ruopp read the Mission Statement. Motion by Meling to approve the Agenda; Second by Bloom. All in favor.

2. Greet Visitors and Hear Citizen Concerns and Comments

3. Approval of Authorizing FEH Design to Create Preliminary Drawings and Renderings for the Bond Vote

Tyler Riley with FEH presented the board with three options to develop concept designs for prereferendum planning for the district. These fees will be credited against the schematic design phase respectively after the voter approval of the referendum and during the schematic design phase.

Option 1: Provide schematic floor plans and site plans for the addition at the elementary and at the high school. No 3D images provided. Estimated fee of \$33,000-\$37,500

Option 2: Provide schematic floor plans and site plans for the addition at the elementary and at the high school. Provide black and white exterior 3D images, one for each school addition. Estimated fee of \$39,000-\$42,000.

Option 3: Provide schematic floor plans and site plans for the addition at the elementary and at the high school. Provide color exterior 3D images, one for each school addition. Estimated fee of \$43,800-\$48,400.

Tyler explained that the schematics would take approximately 3-4 weeks to complete. The board discussed the options and agreed on Option 2. Brief discussion was had on the memorial trees located at the high school. If the bond passes and construction begins, Tyler needs to know what to do with these two trees as they are at or near where the addition would be. Tyler has spoken to local tree companies, and they have the ability to spade and transplant the trees elsewhere on the school grounds. The board is okay with Tyler getting some quotes.

Motion by Ruopp to approve Option 2: Provide schematic floor plans and site plans for the addition at the elementary and at the high school. Provide black and white exterior 3D images, one for each school addition. Estimated fee of \$39,000-\$42,000; Second by Meling. All in favor.
