1. Call Meeting to Order, Read the Mission Statement, and Approve Agenda

Board President Meling called the Special Meeting to Order at 12: 00 p.m. Those in attendance via Zoom: Lisa Meling, Megan Ruopp, and Andrea Terrones. Bloom present at 12:00 p.m. via phone call. Elizabeth Crandon joined the meeting at 12:08 p.m. by Zoom. Superintendent Anthony Ryan and Board Secretary Allison Frost were present at the District Office, hosting the Zoom and phone call. Mr. Ryan read the district's mission statement. Motion by Ruopp to approve the agenda; second by Terrones. All in favor.

2. Greet Visitors and Hear Citizen Concerns and Comments

No citizens in attendance.

3. Approval of Accepting Quote and Authorizing the Upgrade of the Mass Notification Systems.

Mr. Ryan explained that this approval is for the upgrade of the mass notification systems in each of the school buildings. The mass notification upgrade was mentioned in the school safety vulnerability assessment for each of the three school buildings. The district will use the \$50,000 school safety grant money for each school building (\$150,000 total for the district). The additional costs beyond the \$150,000 will be funded by the SAVE Fund. This upgrade will also assist with the improvement of the current PA system limitations currently at the high school.

3 bids were received and presented. RHT Technologies is the lowest bid at \$222,246.96. Shipping of materials will be \$1,270.00.

Board members asked some questions and regarding the purchase. The majority of the equipment is movable, in the event of a building closure. The equipment could then be used in another building. The quotes are a one-time fee for installation of the system and equipment. There is an annual fee for the cloud based software upgrades and subscriptions.

Ruopp made the motion to approve the quote from RHT Technologies, as presented; Second by Crandon. All in favor.
